

In all its proceedings, the Intergroup Association observes the spirit of AA Traditions, taking great care that the Intergroup Association never becomes the seat of perilous wealth or power; that sufficient operating funds, plus a reserve be its prudent financial principal; that none of the Intergroup Association members shall ever be placed in a position of unqualified authority over any of the others; that all important decision be reached by discussion, vote and whenever possible, substantial unanimity; that no Intergroup Association action ever be personally punitive or an incitement to public controversy; that though the Intergroup Association may act for the service of AA Groups in the Northern Nevada area and parts of Northern California, it shall never perform any acts of government; and that, like the Society of Alcoholics Anonymous, the Intergroup Association itself will always remain democratic in thought and action.

# A Box of Pears

All she could give her mother was a little fruit, until someone's share helped her give forgiveness

A few days ago, I was at a speaker meeting in which a woman named Lisa told her story. I didn't expect to hear anything more than I usually hear, which is always helpful in some small way. I didn't expect to be moved more so than I am usually moved. Lisa is half-Japanese. She grew up on Long Island. She is probably 20 years my senior. There's nothing terribly similar about our lives, and nothing stands out to me now as the reason I was drawn to her immediately, but I was. Something about her face was familiar, kind. She started to tell her story, and I was captivated. I could identify, of course, with a lot of her childhood angst and discomfort, but it was more than that.

Before I got sober, I could never really hear anyone. Now I could truly listen to other people. So, I listened to Lisa. She told how at 17 years old she gave up a child for adoption. She described the feelings she had after she gave birth and the child was taken from her.

She said something like, "I felt that all the air had been taken out of me, away from me. I felt empty and alone. I was confused and afraid. I didn't know how to do anything, how to live."

I really heard her. I heard her, and I understood what she'd felt in those terrible moments. And I cried. I tried to dry my tears with one finger, instead smudging the mascara under my eyes. Lisa continued with her story. I raised my hand to share. I don't share very often, not because I don't have joy to share or sadness for which I need support, but because I really do love to listen to my fellows. But this time, I felt a powerful need to share.

I told Lisa and the group that she had given me a great gift: the gift of sympathy. I told her that when I was an active alcoholic, I never felt sympathy. I never felt anything. Alcohol had numbed me for so many years. I didn't even understand what other people meant when they said they felt sympathy or empathy. I knew how to behave as if I felt those same things, but I didn't really feel them. I had, for various powerful reasons, kept feelings at a distance.

I explained to Lisa, and to the group, that my biological mother, who had given me up for adoption at birth and whom I had never known, had tracked me down some years ago.

I had seven Bloody Marys before meeting her. She'd found me, and I was angry. She'd found me, and when we met, she asked me to forgive her, and I didn't say anything. I held on to my anger for a while, and then I let it fade into indifference. I let the relationship become one of occasional emails and the box of pears I sent her at Christmas.

Not once in the years since she found me—her name is Leslie—had I thought about what she had gone through when she gave me up. Not once did I try to put myself in her shoes. And then, I heard Lisa's story. I thanked her for that very precious gift, and I thanked the group and AA for giving me the ability to accept this gift.

I cried. A lot. That evening, I wrote to my biological mother. I told her the whole story. I told her of my anger when she tracked me down, and I told her of my gratitude for AA and for Lisa. This is some of what I said to her in that letter:

"The truth? Being adopted has affected me in many ways, both good and bad. But I'm not writing to you about that today. I'm writing to you to say thank you for making the difficult choice to put me up for adoption. I am so grateful for the life I have had as a result. Until yesterday, I knew it had to have been difficult, but I never fully grasped the pain and fear you must have felt. So, there's this part of me now that wants to say, 'Let's really get to know each other.' There's this part of me that wants a hug from you so much, and to hug you right back. But there's this other part of me that is afraid. I am afraid. But I suppose I hope we can make some small steps forward. Maybe we can just start to email more often and maybe talk sometimes on the phone."

I would never have written that letter had I not learned about listening to other people and feeling sympathy for their circumstances.

### Concept XII - Six Fundamental Warranties Underlie the A.A. Service Structure.

To fully understand the purpose in the writing of Concept 12, it is useful to ask why it was important to write the Concepts at all? A look at what was happening in A.A. at the time gives an answer.

Realizing that he and Dr. Bob would not be around to "head up" A.A. forever, Bill felt it important to turn A.A. ownership over to its groups and its members. This ownership would need to be self-directing, with full participation in the guidance of A.A.'s affairs. A top-down method of decision making would be avoided. Yet, there would be need for a structure that would provide a workable way to facilitate this participation. The 12 Concepts were written to outline the components of the service structure, to describe how they would work together, and to provide the desired group and member participation in A.A. operations.

Development of the 12 Concepts required a way of thinking different from what we are accustomed to in our everyday world. It required thinking in the language of service rather than in the language of governance; to create a structure whose purpose would be to serve rather than to govern.

Concept 12 was originally written as Article 12 of the Charter for the General Service Conference. The Conference structure was developed as a way in which the legal foundation of A.A., its existence as a corporation under New York law, could be integrated with the more participatory form of ownership. The substance of the Conference Charter is not a legal instrument, but exists only as an "...informal agreement which was made between the A.A. groups and their Trustees in 1955." Bill describes the Charter as an "elastic document", but only in part. The first eleven Concepts can be amended by the Conference at any time. A change in Concept 12, however, would require written approval of three-quarters of all directory-listed groups. Making this change was made purposefully difficult, though not impossible. Making both the Traditions and Concept 12 difficult to change was seen as necessary to assure A.A.'s survival and well-being into the future.

The substance of Concept 12 is a list of six declarations that Bill describes as having a"...a high and permanent importance to A.A.'s general welfare". Bill refers to these as the Six Warranties".

- 1. That the Conference shall never become the seat of perilous wealth or power.
- 2. That sufficient operating funds, plus an ample Reserve, should be its prudent financial principle.
- 3. That none of the Conference members shall ever be placed in a position of unqualified authority over any of the others.
- 4. That all important decisions be reached by discussion, vote, and whenever possible, substantial unanimity.
- 5. That no Conference action ever be personally punitive or an incitement to public controversy.
- 6. That though the Conference may act for the service of Alcoholics Anonymous, it shall never perform any act of government; and that, like the Society of Alcoholics Anonymous which it serves, the Conference itself will always remain democratic in action and in spirit.

By protecting A.A.'s general welfare, the six warranties, along with all of the 12 Concepts and the Traditions ensure that A.A., will always be there to serve our members as we work together to support each other in our recovery from the disease of alcoholism. They are important for our survival collectively as a fellowship and for us individually as its members.





# When I was 15

#### An old-timer returns to the scene of a horrible night of drinking

"I'm pregnant." I still ponder pre-drawn sudden wakefulness that always followed my binges of drinking and blackout craziness. Was its cause a physiological response to the overindulgence of alcohol or was it an emotional and spiritual response to the unseemly acts that took place during my drinking binges?

Whatever the answer, this is the statement that jolted me awake one August morning in 1973 when I was 15 years old. We had moved to Florida from upstate New York five short days prior. I was very distraught about the move from its inception, being forced to leave all that I loved -- a grandma, a boyfriend, a girlfriend, the only school I'd ever known and a hometown full of my growing up--for what my parents thought was paradise.

The day before, my parents and I had set out to have a day at the beach. We ended up in Cocoa Beach, about a two-hour drive north from where we lived. I remember that there was ocean and sun and sand all the along the top portion of the beach, there were bars.

I had begun drinking in New York when I was 14, after being rejected from the cheerleading squad in my freshman year of high school. I had suspected all along that I was not good enough, not only for the cheer-leading squad, but for life in general and this event confirmed it. When I began drinking behind the school during the same basketball games that I had hoped to cheer for, I found the magic that alcohol held for me: release from the "not good enoughs." From that point on, alcohol was my higher power.

On the beach, I found myself alone after my parents went off to find their own good time. No cell phones existed to keep in touch and I was left to freely explore. I know today that only my Higher Power kept me alive that day. Over the years since this happened, vague and desperate memories have surfaced of the places alcohol took me that day: to a bar with strange men; into the ocean, drunk and swimming with someone I did not know; searching for my bathing suit top in the ocean waves; in a van having sex; and being involved in a car accident on the way home.

I'm pregnant, I thought the next morning. I knew it from deep within my soul. And so it was.

*I* was in a new state with not one friend in whom to confide. It was one year after the Supreme Court case of Roe vs. Wade had legalized abortion, but long before it was a widely accepted practice, especially in the deep south. In late September 1973, after an agonizing month of isolation with my secret, I told my parents, and terminated my pregnancy. Those of you who are familiar with the darkness of alcoholism will understand that the serious nature of this event might have looked like one of those "jumping-off points" that the Big Book speaks of, whereby we are faced with the seriousness of our alcoholism and its consequences and make a decision to change. In fact, this was only the beginning of my journey to hell and back. For 15 more years, I drank and damaged myself and others as only an untreated alcoholic can. However, by the grace of God, I married and conceived three children, all planned and deeply loved.

Through it all, I carried with me the shame, sadness and pain from that day at Cocoa Beach.

One morning in 1989 when I was 30, after a drinking binge. I was jolted awake in much the same way as I had been on that August morning in 1973. This time though, it was my Higher Power whom I listened to, and as I looked into the blue eyes of my 9-year-old daughter he gave me the words that I heard myself speak: "Mommy drinks too much and she needs to get help in AA."

"OK," she replied and smiled up at me with the assurance that only a 9-year-old can have when placed up against such a challenge.

I called the AA hotline and with-in half an hour, word spread along the AA airwaves in our little town and a woman called me, took me to my first meeting that evening, and became my sponsor. From the instant I made the call, I felt a great relief and a great power, and I felt like all would be well. I am sober because I was shown by my sponsor how to trust God, clean house, and help others through the program of Alcoholics Anonymous, I have had the spiritual awakening described in Step Twelve and I carry the message to alcoholics who still suffer and practice the AA Principles in all of my affairs to the best of my ability one day at a time. If I don't, I return to my baseline of "restless, irritable and discontent," and we all know where that ultimately leads: to the first drink. And for me, to drink is to die. In February 2010, I celebrated my 21st year of sobriety.

My story could end here, but there is more. In February 2009, my husband (who has an AA recovery story of his own) and I traveled to Florida for a winter vacation. One night while driving back to our hotel from dinner, a sign caught my eye. It said, " Cocoa Beach--15 miles."

My husband knew of that fateful August day in 1973 and later as we sat on our hotel balcony overlooking the dark night ocean, I asked him if he had seen the sign. He had. "Could we go there?" I asked him, not really knowing why, but sensing an urgency to go.

"Of course," was his reply. "When do you want to go?" We went the very next day. Our plan was to try to find, using only my very vague memory, the area where I had been so many years before. Even though I had dealt with this misadventure in my Fourth Step many years ago, the proximity to the location stirred the remaining demons inside of me as we drove toward the beach. We parked and walked and sure enough we found the same ocean, sun, sand--and bars. We walked without plan or talk. We went inside one bar and asked about its history. Had it always been there? Under the same name? It wasn't quite right.

We walked back out into the sunshine and there, across the sand, I saw it. Actually, I felt it. We went inside this bar and it was the same one from my desperate memories. My husband stood and waited while I walked across the floor toward the bathroom. I let every ounce of my sobriety flood me and shield me and project me across the floor. As I used the bathroom, I imagined myself as that adolescent girl in her bikini in this bar with strangers, drinking underage and alcoholically, so many years before. My beautiful, loving husband was waiting for me and we went back into the sunshine onto the beach.

As sponsors, my husband and I complete the Twelve Steps with new people using the Big Book of Alcoholics Anonymous in the way that we were shown by our sponsors. After completing the Fifth Step, we burn the Fourth Step list to symbolize the end of the old alcoholic thinking and behaviors. It proves quite emotional for those who are ready to change. In the hotel the night before, I had written a letter to myself about the tragedy that had occurred on the beach so long ago. I now opened it and read it aloud while my husband held my hand. In it, I asked God to help me forgive that young girl and allow her to be free of the pain and sickness that held her captive. I let go of the lingering resentments toward my parents, whom I felt deserted me that day, and of the others whom I allowed to hurt me. And I thanked God for the life of sobriety that has been so freely given to me today if I but work for it. Together, my husband and I knelt and lit the paper afire. We watched it burn to ashes in silence, we recited the Third Step prayer and the Seventh Step Prayer. Then we walked hand in hand across the street to the AA meeting that was about the begin.
